CRITERIA FOR INDIVIDUAL MEMBERSHIP

The SLIM Membership has five categories, namely: Honorary Member, Fellow Member, Member, Proffesional Member and Associate Member. In addition to these membership categories a special student membership is also offered to students who are following Marketing Education Course/s conducted by SLIM.

The Annual Subscription shall become due on the first (1st) day of January every year and shall be in respect of the year ending on the thirty-first (31st) day of December. However, any member obtaining new membership on or before the thirty-first (31st) day of August in a given year shall be required to pay the full Annual Subscription fee. New members joining between the first (1st) day of September and the thirty-first (31st) day of December shall be required to pay only half of the Annual Subscription fee for that particular year. The full Annual Subscription fee shall be payable from the following year onward. Therefore, all members are encouraged to pay the membership fee at the beginning of the year.

Grades of Membership

1. Fellow Member

FELLOW MEMBERS will be awarded the membership pursuant to an invitation being extended by SLIM (the Executive Committee) after having received a unanimous approval from the committee appointed for the awarding of Fellow Memberships, pursuant to being Members of the Institute for over five (5) years and have distinguished themselves in the field of Marketing and Marketing Management.

2. Honorary Member
